

# Governance Board Meeting Agenda March 26, 2022 | 9am

## Actions taken by e-mail since our last meeting:

**Church Mask policy:** On March 1, Kelly proposed the masking requirement end for in-person worship and other church events (with the exception of nursery and children, as they follow a separate mask policy approved by the board on 1/31/2022.). The following language for congregation communication was proposed:

- Masks are no longer required for attending worship or other in-person adult events at the church.
- Nursery, children and youth will follow a separate mask policy proposed by staff and approved by the Governance Board on January 31, 2022.
  - Masking will remain mandatory for Sunday School until 60 days past when the vaccine is available for kids ages 3 & 4.
  - o Masking will be optional for all EDGE events
  - o Masking will be optional for all YOUTH events
- Following CDC guidelines, we ask that you wear a mask if you are symptomatic, have tested positive for COVID or have been in close contact with someone who has tested positive.

• The Governance Board will continue to monitor data and adjust this policy based on data and guidance provided by the Ottawa County Dept of Public Health, the Michigan Dept of Health and Human Services and the CDC.

VOTE: All in favor, none opposed. Motion passed.

Kelly shared a devotion about mindfulness - Seven Christian Mindfulness Exercises to See God in Daily Life. Kelly led the board in prayer.

  of the General Conference. There is a possibility that Sherri could be

- The study group, "Sinning Like A Christian", meetings on Thursday and there are 9 participants.
- New member class after Easter 3 people.
- Ash Wednesday included imposition via drive thru (12 people) and 17 people for an in-person service.

The board asked about taking some load off Sherri and help with any follow up. A suggestion was made about holy week messaging/communication. Sherri stated she would be putting together a paper letter for Easter.

• Is there a threshold for when to implement again? The previous threshold was 10%. Should we consider new CDC guidance and look at the color coded map – green, yellow, orange.

MOTION: Karen A. made the motion that we use the CDCs integrated county view. If green, masking is optional; if yellow, masking is encouraged; if orange, masking is required. The Governance Board will continue to monitor.

SECONDED: Sue seconded the motion.

VOTE: All in favor, none opposed. Motion passed.
