1. Devotions

2. Pastor's Update

Pastoral

• Some outdoor signs on 28th Ave. side have been removed but not yet decided on how to replace. Sherri and Amy are looking into possibly getting letters on all main doors (i.e. Door A, etc.).

Softball Field

• Getting a lot of use by two non-church groups. GUM is receiving a nominal fee for that use.

Trustees

• At the last Governance Board meeting (July 25 minutes), the Governance Board asked that Trustees look at other companies with whom to do business with for our landscaping needs. Todd. P. had a long conversation and does not want to "throw out the baby with the bathwater." They have been reliable and manage the property at a high level. They even recently added new benches at the softball field. Pete (owner of Priest Landscaping) and Todd feel there is good communication now. Additionally, leadership will be changing in 2023 and perhaps the new chairperson would like to revisit this then.

Congregational Care Team

a. Kelly -

SPRC: Putting on pause Assistant Director of Young Disciple's position. Hired Kerri for additional 10 hours/week temporarily.

4. Old Business

a. Kickoff Sunday Recap (September 11):

Well-attended and well-received. 169 in worship, 21 kids in Sunday School, 3 babies in Nursery, 7 Edge and 9 Youth at their kickoff events. 10 members returned after being gone for a while, 10 new guests and 10 who joined later for meal and activities. Staff and volunteers did a fantastic job!

b. Finance Committee joint meeting (August 16):

Cross Committee conversation. There was good conversation and ideas, however, no plans for follow up were made. One of the ideas brought up was moving to only one service. Staff discussed and were open to it but would appreciate advanced planning and if a decision was made, that it would be made by the end of Oct. for implementation in January. Governance Board needs to schedule a meeting in Oct. to discuss this idea. Kelly will propose two dates to the Governance Board – Saturday, Oct. 15th or Monday Oct. 24. for this special meeting. In the meantime, guidelines for what we should look for include: Attendance, staff feedback, new visitors, etc. Also discussed was the idea of the return of "flight plans" for starting groups. This discussion will be added to the agenda for the November meeting.

- d. New member buddies:

New member class is on hold, so we'll move forward with new member buddies with the next group.

 e. Native American Awareness – statement of land acknowledgement: Michelle found an example of one that she will share by email to Governance Board for further review.

5. New Business

a. Christmas Day:

Pre-recorded service by Conference will be shared. Should building be opened on Christmas Day? Can we offer online only? Those in attendance affirmed and Kelly will ask by email for affirmation by Governance Board not in attendance.

Action taken by e-mail since meeting:

In email, Kelly asked the board the following: "We discussed keeping the building closed on Christmas Day. A lot of effort will go into 2 Christmas Eve services and on Christmas Day, a pre-recorded service will be shown. The recording will be made available during the regular worship service time online, which Alex can set up in advance. We all agreed that it makes sense to keep the building closed and encourage people to watch the recording from home. **Let me know if you support keeping the building closed on Christmas Day."**

VOTE: All in favor, none opposed. Motion passed.

b. Rainbow doors maintenance:

Spring of 2024 is general conference and doors will be out until then. Open door committee is now defunct. Should they be replaced with something else – banner, feather flags, etc.? Or can someone maintain the doors? Decision to wait and see how they look in the Spring. May have to repaint in the Spring. If office staff notice the doors have fallen and cannot put them back up, notify Michelle and Kelly and they will make plans to take care of.

 c. COVID policy update (addition to agenda): Due to CDC guidance continually changing, should our policy change to follow that? Kelly will add to email to ask for email vote.

Action taken by e-mail since meeting:

In email, Kelly asked the board the following: "We discussed the fact that our current COVID policy is in conflict with current CDC guidelines, which is confusing. We discussed repealing the current policy and replacing it with a simple statement like "For all matters related to COVID-19, GUM Church will follow and ask that members and attendees follow guidelines provided by the Centers for Disease Control (CDC). Current CDC COVID-19 guideline can be found online at https://www.cdc.gov/coronavirus/2019-ncov/yourhealth/index.html. Let me know if you support this change to repeal the previous COVID-19 protocols and replace it with the previous simplified statement and reference to the CDC guidelines."

VOTE: All in favor, none opposed. Motion passed.
